Final Judgment and Next Steps on Watson Estate: Background:

On June 16, 2021, the Presbytery of Waterloo-Wellington was contacted by the Public Guardian and Trustee Office of Ontario (OPGT). The OPGT informed the Presbytery that Jean Mary Watson, formerly a member of Knox's Galt Presbyterian Church, died on February 15, 2021. Her last Will and testament, as it specified a charity as beneficiary, was passed to the office of the Public Guardian and Trustee. In the Will, dated December 1st, 1983, Jean Mary Watson appointed Rev. Robert Jackson of Knox's Galt as her executor and trustee of the trust expressed therein. Further, Knox's Galt would be the beneficiary of 10% of her net estate. The estate consisted of a house and land at 715 Main Street East Cambridge (est. value \$575,000) and investments and cash totaling \$161,000.

The balance of her estate was to be held in trust, for the issue of two of her late husbands, to provide special treatment (medical and equipment) to those eligible under the terms of the trust; because of "handicap, disease or illness", from birth to 25 years. Further an allowance of \$300 dollars a month would be provided to same individual(s) from the ages of 18 to 25. The trust would exist for twenty years and the residual of the trust would be given to Knox's Galt.

Procedural Summary

The OPGT was unable to locate the Rev. Jackson as he had predeceased Jean Mary Watson; and were also unable to contact a representative of Knox's Galt, as it had been dissolved by the Presbyter on June 28, 2020. Subsequently the OGPT contacted the Presbytery as the successor to the congregation of Knox's Galt. In August 2021 our lawyer Paul Grespan of McCarter, Grespan, Benyon, Weir (MGBW), updated the business committee on the approach the Presbytery would need to follow to probate the Will as the appointed executor, and the subsequent beneficiary, were extant.

When the Presbytery received its copy of the Will from the OPGT on June 16, 2021, it was immediately responsible for the property at 715 Main Street. This included the payment of all taxes, utilities, sourcing vacancy insurance, as well as the security and maintenance of the property until such time as it was liquidated. The Presbytery could not remove anything from the property until the court granted permission to sell. Gib McIlwrath took on the leadership for this work, with the help of Vern Platt. At the time, it was anticipated that the court order application would be filed within weeks and a final judgement from the SCJ(K) would be forthcoming by late 2021, with a sale of the Property completed by Q1, 2022.

It became clear that the Presbytery did not possess the legal standing as the successor beneficiary to a dissolved congregation. Also, no representative of the Presbytery could fulfill the role as the appointed executor and trustee. Further the Act to Incorporate the Trustee Board of the PCC, 1939 did not provide a clean chain of representation as to senior officials and successorship to dissolved congregations. On August 31, the Trustee Board of the PCC became the proposed successor to Knox's Galt. The Principal Clerk agreed to be the executor and trustee.

Affidavits stating that the PCC Trustee Board was the cy-pres successor beneficiary, and that the Principal Clerk was the senior minister of the PCC pursuant to the Act to incorporate The Trustee Board of the Presbyterian Church in Canada, 1939; were composed. Upon filing in January 2022, it was estimated that 8-12 weeks would be required to complete probate. In the interim, Trent Johnson of SV Law was appointed the litigator. A retainer agreement was signed on May 26 before the June 2022 filing of the final court order application with the SCJ (K). A hearing was scheduled for July 27,2022 however it later translated to a Justice reading.

It is required in Ontario, that when serving documents to the crown in a civil case affecting trust beneficiaries under the age 18, it is also required that the application materials be provided to the Office of the Children's Lawyer (OCL). This was done concurrently with the final court order filing. It was not until July 29, after the justice reading on the final application had begun, that the OCL applied to intervene. However, as of October 1, 2022 the position of the OCL was not presented to its local legal representative.

Four months of continuing delays by the OCL led to the filing an application for interim relief. Specifically, permission was sought to sell the Watson property at 715 Main Street Cambridge, and to liquidate all investments; and to place the proceeds of both in a trust account administered by MGBW. This application was granted quickly on Oct 6. Once the property was sold and the trust account established all further legal expenses of MGBW would be paid by the trust account.

Starting in October, 2022, work began on preparing the property for sale. Gib McIlwrath and Vern Platt worked over the next several months to sell, auction, donate and dump the contents of the home. It was hoped that most of the content would sell via online auction held in early 2023. This was not the case and the vast majority of the contents were donated to thrift stores or the local landfill. Gib and Vern devoted hundreds of hours to preparing for the listing of the property. Their work realized an offer much higher than originally estimated in June 2021. 715 Main Street, Cambridge was placed on the Market in late February, 2023. A conditional offer of \$650,000 was received on March 6 and the net sale at the time of closing on April 28, 2023 was \$603,647.70.

A few modifications were made to the original May draft final order application, before it was submitted to the court in late October. The first four orders and number #6 remained the same. The OCL requested the fifth order. Order seven was added in October to ensure SVLaw (our litigator) would be paid from the estate and that any invoices we paid would be refunded. Order 8 came with the OCL package the day before we filed. It is not untypical that legal counsel of the OCL is paid by the filing party, especially after providing so many concessions.

It has been almost thirty months since the receipt of the Last Will and Testament of Jean Mary Watson. Legal proceedings have endured 28 months. The pandemic impacted the proceedings due to shutdowns, delays, in the SCJ. A typical 15-day turnaround or decision extended to 6-8 weeks. The pandemic added approximately 4-6 months to the initial timeline. The unexpected intervention of the OCL in July 2022 further delayed and complicated the proceedings. The OCL's unclear and shifting instructions to their local legal counsel, and objections to minute items and document language, resulted in total delays of 8-10 months and additional legal costs approaching \$40,000. The proceedings, even with its unique complications, should have taken no more than a year to complete.

Decision

The final court order or final judgment of December 5, 2023 confirmed the interim decision appointing Principal Clerk, Victor Kim, as the Estate Trustee. This decision impacted order #2 as the Presbytery could not be the beneficiary of any funds bequeathed to a congregation that had subsequently been dissolved and did not meet the cy-pres. doctrine requirements. Thus, the trustee board was the only body in the PCC who could. Order #3 flows from Order #2, Orders #4 and #6 flow from the flows from both order #1 and #2.

THE HONOURABLE JUSTICE G. E. TAYLOR, ONTARIO SUPERIOR COURT OF JUSTICE, December 5, 2023

THIS APPLICATION, made by the Trustee Board of the Presbyterian Church in Canada, for a final Judgment on the balance of the relief sought in the Notice of Application was read this day at the courthouse at 85 Frederick Street, Kitchener, Ontario, N2H 0A7.

- 1. THIS COURT ORDERS that Victor Kim, the Principal Clerk of the Trustee Board (the "Trustee Board") of the Presbyterian Church in Canada, is hereby appointed the Estate Trustee (the "Estate Trustee") for the Estate of Jean Mary Watson, deceased (the "Estate").
- 2. THIS COURT ORDERS that ten percent (10%) of the residual of the "Watson Estate" be distributed to the Trustee Board in accordance with the cy-près doctrine, as provided for in the Last Will and Testament of Jean Mary Watson executed on December 1, 1983 (the "Will").
- 3. THIS COURT ORDERS that the residue of the Estate which remains, if any, after the winding up of the trust as provided for in paragraph III(c) of the Will shall be distributed to the Trustee Board in accordance with the cy-près doctrine.
- 4. THIS COURT DECLARES that the Estate Trustee has sole discretion to determine such amounts of the income and capital of the trust to be paid in accordance with paragraph III(c) of the Will.
- 5. THIS COURT ORDERS that the Estate Trustee is to provide draft accounts to the Office of the Children's Lawyer two (2) years after the date of this Judgment, and to pass Estate accounts if required by the Office of the Children's Lawyer or the Court, and thereafter provide draft accounts if requested by the Office of the Children's Lawyer.
- 6. THIS COURT ORDERS that the Estate Trustee may apply or move before the Court for directions, guidance, and advice as to the proper administration of the Estate, in accordance with the Rules of Civil Procedure.
- 7. THIS COURT ORDERS costs of this application are payable from the Estate to the Applicant of \$36,749.99 plus HST of \$4,777.50 for a total of \$41,527.49.
- 8. THIS COURT ORDERS that the Children's Lawyer's costs of \$9,494.82 plus HST of \$1,234.33 for a total of \$10,729.15 shall be paid from the Estate to Casey & Moss LLP within 30 days of this Judgment.

Estate Condition

As of September 6, 2023, the trust was estimated to be valued at \$726, 664.

Between September 6 and December 5, 2023, the following amounts were identified as deductions to the trust's value:

- 1. \$81, 476.39 in legal expenses for the period from September 1, 2021 to November 1, 2022, the date of the interim court order.
- 2. \$41, 527.49, court expenses payable to SV Law by the estate as per the final judgement. (To be executed)
- 3. \$10, 729, reimbursement of legal costs of the Office of the Children's Lawyer as per the final judgement. (To be executed)

- 4. \$3, 068.77, MGBW invoice amount for September and October, 2023, to be paid from the trust account. (To be executed)
- 5. \$7,574.92, MGBW invoice amounts for October, 2022 and one payment for 216946 for November 2022 (216496 should have been paid by the estate.)

Total: \$144,376.57

 provides the Trustee with the authority to manage the trust assets and expenses. Within 180
 calendar days of receiving a certificate, the Trust must file an Estate Information Return with the
 Ontario Ministry of Finance, listing the value of the deceased's assets at the time of death. (January
 2024)
- 2. Filing an Estate Information Return, with the Ontario Ministry of Finance is required within 180 days of receipt of a certificate of appointment. As this filing is necessary to reimburse outstanding costs, this should be done immediately. (Feb. 2024)
- 3. A T3 "Trust Income Tax and Information Return" filing with the CRA must be completed after the receipt of the Estate Certificate. An application for a trust account number to initiate the filing is required. When the Trust Account Number is received, the filing of the T3 Information Return must be filed within 30 days. (February, 2024)
- 4. Order #7 provides for the payment within of the court costs of \$41,527.49 to SVLaw Group, pursuant to the receipt of clearance from the CRA (see above). (March 2024)
- 5. Reimbursement of Costs: Once the court order has been implemented and the trust is registered with the CRA and Ontario Ministry of Finance, the estate trustee, will be able to order the payment of the balance of the Presbytery's property maintenance and legal costs. In preparation, an audit of all invoices and payments will be conducted. PWW has paid \$89,051 to MGBW prior to the interim order of October 2022. PWW will also be reimbursed for the payment of any invoice now covered under Court Order #4 and any amount above that. Outstanding amounts are to be paid by the estate. (March 2024)

Future Administration

All trusts are required to file an annual T3 Return with the CRA. The "Watson Trust" falls under several criteria of trusts, including:

- a. 1) Total income is greater than \$500, 2) income (in the form of Interest) of more than \$100 which will be allocated to any single beneficiary.
 - b. It is also a "Listed" trust in that: 1) it has been in existence for less than three months at the end of the year; and 2) holds assets with a total value greater than \$50,000.

c. It is also an "Express" trust as it was created with the settlor's express intent (Jean Mary Watson), in writing (Last Will). (By March 31, 2025)

The Rev. Diane Boyd was born on June 23, 1969, in Guelph, Ontario. She passed away far too soon, on December 21, 2023, following a courageous battle with ovarian cancer. She was 54 years of age.

Diane was the loving wife of Robert, and devoted mother of Kaleigh, Abigail, Robyn, and Ben.

Diane earned a Bachelor of Arts in Psychology from the University of Guelph and went on to attain her Master of Divinity from Tyndale College and Seminary. After choosing to be home with her children for more than 10 years, she then graduated from University of Toronto Knox College, with a Master of Theological Studies, in 2017.

In Guelph, Diane pastored the Riverside Community Reformed Church during a transition period in 2018 and served as a Pastoral Visitor for St. Andrews Presbyterian Church from 2019 to 2022. Jeff has offered to continue working with their leadership through into May, Courtney has offered to look after emergent pastoral care needs, and Mark has agreed to seek pulpit supply to start the beginning of February 2024. Therefore

Recommendation #3: moved by Doug McCaig, seconded by Kristine O'Brien that the Presbytery approve the appointment of the team of Dr. Jeff Crawford, Rev. Courtney Crawford, and Dr. Mark Richardson to the position of Interim Moderator of Knox PC, Preston effective 31st January 2024.

Interim Moderator Reports:

A) Interim Moderator: Rev. Calvin Brown, January 2024, Knox-Calvin PC, Harriston. Administration/leadership:

Session continues to work with the Search/Futures Committee in preparing to be ready for receiving a new minister.

The Session is composed of four elders and the IM, and meets monthly with assigned tasks in between. Two of the Session are on extended terms and at least one long serving elder has indicated he will not let his name stand again to serve after the Annual Meeting in February. We desire to be proactive in having candidates to present to the Annual Meeting but in the event we do not find suitable candidates the reduction in the size of Session will be severely felt.

The Board of Managers has determined we have enough funds to call a half time minister. They were also asked for and produced a schedule of fees for the renting of our building to outside groups.

The Search/Futures Committee meets monthly and works on being prepared to interview a candidate.

We are well represented at Presbytery by Elder Dave Mallott.

Activities:

At the instigation of a member of the congregation and enabled by Session we held an Advent Fellowship and fund raiser after Communion.

The Chilli lunch was followed by a silent auction. It was well attended and considered an encouraging success.

The Sacraments are celebrated regularly with an infant baptism held last quarter and Holy Communion held quarterly. Several funerals were also catered to. Regular Pulpit Supply has been arranged and is set until mid-May. There have been a variety of speakers all of whom have been well received and their messages appreciated as helpful.

Search/Futures Committee

KNOX/CALVIN HARRISTON SEARCH COMMITTEE REPORT

The Search Committee and Session want to share with you the progress of the Search/Futures Committee in the search for a new minister of the Word and we ask for your prayers for guidance and any thoughts you may have on the subject. The following are some of the proposals we are considering.

- 1) Request Presbytery to allow us to Change from ¾ time minister to ½ time minister. It was felt half time was all the stipend we could guarantee.
- 2) In January request Presbytery to give us permission to Search for a ½ time minister either as a Stated Supply who would be appointed annually by the Presbytery in consultation with the congregation with the task of preaching each Sunday and doing regular pastoral work and working with the congregation in future planning or else a short-term minister or by calling a minister through the regular call procedure.
- 3) Continue to participate and dialogue with the Cooperative Congregations in northern Wellington Presbytery who are also in vacancy mode to see what ministry options can grow with them.

The following motions be made:

- 1) The ministerial position at Knox Calvin, Harriston be changed from 3/4 time to 1/2 time.
- 2) Permission for K/C Harriston to seek a ½ time minister.

B) Interim Moderator Rev. Howard Sullivan, Kortright PC, Guelph:

By the grace of God and through his blessing:

Kortright Presbyterian Church, Guelph, ON, continues to do well, since the spring 2023, when I was appointed Interim Moderator. The congregation has been ably served by a variety of supply preachers along with sound preaching from two current staff. As interim moderator, I have been preaching about once every six weeks to stay connected with the congregation and have also kept them informed of our progress in the search for a new lead minister.

Since preaching the pulpit vacant Sunday, April 23, 2023, we have worked diligently to ensure the congregation remains active, is well supported, and prepares for the next minister. Among other things, we have established new outreach, the Dovercliffe Park Food Cupboard, in collaborative with the Guelph Food Bank. We have introduced new small group resources and continued to establish sound policies and practices. I believe the cooperative working of Session and myself has aided in much of this progress.

At KPC, we determined that the search process really involved two elements each of which required people with certain abilities to be accomplished. Therefore, we divided the typical search team into two parts: the profile team and the interview team. Presently, I am working with the profile team to complete our documentation and create an attractive profile for KPC. This team consists of eight people chosen and vetted by Session for teir skills in research and drafting the profile documents. The chairperson of the team is Eric Goforth, a young man, who recently joined the church. We have begun the important work of creating our congregational profile following a survey of the congregation. The survey took place over a three-week period, approximately 140 surveys were completed. We anticipate our final version of the profile will be ready for January 2024 as we launch into the exciting aspect of the search process—finding our next minister.

Session, which has a small number of elders (six) meets each month and is accomplishing a great deal. A challenge we have undertaken is the revamping of operational procedures in consultation with Relational Systems Consulting (the Rev. Douglas Schonberg). We are holding elder elections this coming spring and hope to expand the Session to at least eight active elders. We have worked through the staff restructuring that Rev. Alex MacLeod introduced prior to his departure. This has changed the reporting of staff as well as redefined the responsibilities of one of our part time staff. I remain yours, in Christ's service,

C) Interim Moderator Rev. Dr. Peter Bush, St. Andrew's Presbyterian Church, Gordonville and St. Andrew's Presbyterian Church, Arthur:

The Congregational Profile was completed in the week before Christmas and is being circulated. There have been 9 people request a copy of the profile, a couple of candidates have submitted their profiles and some others have indicated their intention to do so.

Supply is in place until Holy Week, 2024.

Both congregations have taken new initiatives in the last 4 to 6 weeks. Arthur held a lay led Advent Bible Study. Gordonville did activities and a community brunch with their Christmas Pageant.

D) Interim Moderator Rev. Dr. Peter Bush, The Presbyterian Church of Rockwood:

With deep sadness the congregation has noted the death of the Rev. Diane Boyd on Dec. 21, 2023. The congregation gathered for a special time of prayer at the end of the worship service on Dec. 17, to pray for Diane and her family.

The Rev. Darrell Clarke has been doing the majority of the supply preaching since the middle of October 2023 and will do so through until at least Easter 2024. That is as far as the conversation has gone. The thinking at the moment is in late February to begin talking about the next steps at Rockwood. Until that time, it is important to not overthink what that future might look like.

E) Interim Moderator's Report for St. Andrews Guelph

We are in a bit of a holding moment right now. There have been no qualified interim ministers. It has caused us to pause and consider the New Beginnings Program as a possible alternative. We ask for prayers.

Christmas & Advent services were well attended and a festive spirit was had by all. A joint program with Knox Guelph was held at St. Andrew's on Dec. 3rd with a pizza lunch and some wonderful music and singing that followed.

The Board did their work in presenting a budget for 2024. This was taken to a congregational meeting on Dec. 10th where it was passed with hope of new things to come.

Pastoral care continues to be covered by Rev. Mark Gaskin and pulpit supply is covered to the end of June.

F) Interim Moderator Report Knox Presbyterian Church – Guelph

Rev. Cathy Stewart has been well received in her role as Interim Minister. She is familiarizing herself with the identity and inner workings of Knox, and bringing her creative presence into their midst. We have established a good working partnership and are developing strategies for leadership development, and preparing the church for the next phase of its life and mission.

To that end, the Knox Session has agreed to apply to the New Beginnings Program with Canadian Ministries. They believe that this is the right process for discerning their options for the future, especially as it will be guided and resourced by their Interim Minister.

The new Church Administrator has adapted very well to her role, and has brought stability to that position.

Unfortunately, a well appreciated Church Musician is moving on, so it will require some effort to find a replacement.

All that being said, there are signs of hope.

Grant from Re-Generation Fund

The Re-Generation Fund has \$35,000 available in 2024. No grants will be for more than \$5,000. No single congregation will get more than \$5,000 in 2024.

Grant Request:

St. Andrew's Church, Fergus, is learning to join the community in what it is doing (Luke 10:1-11). To be in the community outside of being the church at the top of the hill. To that end we have be present at the Home and Leisure Show, the Medieval Festival, and the Fergus Fall Fair. We are sponsoring ice time at the local arenas, for free public skating, we are present in the Santa Claus Parade, and we have operated children's programming in the public parks.

It is support for the first three of these ventures that we are seeking grants from the Presbytery. At the Home and Leisure Show and the Fall Fair we gave away books and other resources related to self-help, spirituality, the story of Jesus, and live Christian-ly in the world. We were also present to have conversations with those who dropped by the booth, and we had a presence in the community. Members of the congregation staffed the tables/booths, being willing to be connected with church and faith in the Triune God of grace. There is no cost to have a booth at the Fall Fair, there is a cost to be present at the Home and Leisure Show.

The Medieval Festival is a completely different kind of thing. There we operated a water station while being dressed as monk. The Medieval Festival takes place on St. Andrew St. (Main St.) in Fergus in July – it is often hot and people get thirsty and we provided free water in environmentally sensitive ways --

with reuseable water bottles and compostable cups. Some people coming to get water connected that the church was serving the community. We calculate that in 2023 we served water to 800 people.
