The second purpose of this emergent meeting is to report and recommendation of the Business Committee in response to the letter of June 10, 2021 from Gale PC, Elmira; and recommendation for a loan to Knox PC, Palmerston. The Business Committee has taken the liberty, and with the indulgence of the Presbytery to seek the approval of grants received since the last regular meeting.

The third purpose of this emergent meeting is to receive and consider a report from the Pastoral Care/Pastoral Relations Sub-Committee of the Ministry Committee.

**Amalgamation of the Congregation of Westminster-St. Paul's, Guelph.**

**The Commission on Assets approval of the amalgamation plan of Westminster St. Paul's PC, St. Andrew's and Knox PC, Guelph, with its distribution of assets as presented was received on June 22, 2021. Thus:**

### **Ministry Committee Report “Appendix A” – Rev. Ed Charlton Report and Recommendation: Pastoral Care/Pastoral Relations Sub-Committee**

Standing orders 7.5 established a Pastoral Care/Pastoral Relations Sub-committee “to give pastoral support” to professional Church Workers within the bounds of the presbytery. Said committee was to be a sub-committee of the Ministry Committee.

Appendix B establishes the Presbytery Trust Fund “to assist in meeting compassionate...need...in the event of...the necessity of pastoral care among the Presbytery’s servants within the bounds.” Appendix B.2 states “The Trustees will disburse the Fund’s assets on the instruction of the Pastoral Relations sub-committee of the Presbytery.”

COVID has been a major stressor in the lives of clergy, including the clergy in the Presbytery of Waterloo-Wellington. As things “re-open” a new set of stressors will impact ministers who are already exhausted. Presbytery has a responsibility for the psychological, emotional, and spiritual well-being of the ministers within the bounds.

On the basis the material above the Ministry Committee of the Presbytery functioning as the Pastoral Care/Pastoral Relations Sub-Committee has decided to use funds from the Presbytery Trust Fund to enable every minister on the roll (and Others on the Roll) of Presbytery and spouse to have a 2 night/3 day (6 meals included) time away at Crieff Hills Community. We recognize that clergy with younger families may wish to bring their children with them to Crieff, the presbytery will cover the cost of school aged children to accompany their parents.

The process would be that those wishing to take up this opportunity would contact Crieff Hill Community to book their two-night stay at The Pines. Upon arrival at Crieff they would follow the details regarding check-in, meals, etc. At the end of their stay the Presbytery would be billed. Crieff will bill the Presbytery of Waterloo-Wellington once a month for the stays occurring in that month. Crieff would be provided with a list of names of those eligible to take up this opportunity.

In conversation with Crieff Hill Community – with 24 persons eligible to have this retreat time – the cost would be about \$11,760 (plus taxes - \$1,530) – so \$13,280. That is if everyone were to use this opportunity. These funds to come from

#### **a. Request for funding, Westside PC**

##### **EG21-01: request for Funds from the “East Galt” Fund re: Westside Sports Camp**

At its March, 2019 meeting, the Presbytery passed a recommendation from the Mission and Outreach Committee. The Committee's recommendation was in support of Westside's 2019 request for a grant from the Presbytery Fund that had been set aside for “supporting outreach ministries in the area of East Galt.”

Due to the Covid-19 pandemic there was no Cambridge Sports Camp in 2020.

This year (2021) we are holding a 3-day Sports Camp at Westside from August 16 to 18. On behalf of the Session of Westside Church we are making a request for 2021: “that the Cambridge Sports Camp be granted the amount of \$2,500 for 2021 from the funds set aside for “supporting outreach ministries in the area of East Galt.” The two areas that the grant supported in 2019 were advertising and camperships. Because of the Presbytery's generosity we were able to cover large neighbourhoods with leaflets and postcards, and provide subsidies for almost half of our campers. Thank you for your attention to this request.

Gale Presbyterian Church has been in our new location and building for 9 years. We continue to thrive in our new neighbourhood. We provide a valuable worship and community space to many people in Elmira and the surrounding area. We are pleased with the steady repayment of our outstanding loans over these years and are confident they will be retired in due time.

In December of 2018 we approached the Presbytery for financial assistance to add to our team a Faith Development Facilitator. A position description and budget were included at that time. The budget depended upon financial support from the Presbytery as follows:

The session of KPC proposes a new design for the front of the Sanctuary space, improvements including a sound and IT platform. The goal of this project is to create a more relevant, open, and connected worship environment inside the Church building showing acceptance, love towards everyone, and for all generations.

We are looking to create: a physical and spiritual space where worship is accessible to people of all abilities, creating opportunities for individuals to respond to God in a variety of multi-sensory ways, including sights and sounds. In accessible worship, we engage with God and with one another. In our days, audio and video systems, and physical settings are becoming more and more prevalent in the worship environment as a way of engaging the worshipers more than just the auditory system.

A new design of the front part of the sanctuary and the support of the technologies will eliminate the invisible line that exists between the front edge of the stage and the rest of the room by engaging everyone in the whole experience of worship and fellowship.

Below is proposal explaining what we are going to be doing:

We request \$5000 from the Development. A further application for funding may be forthcoming once the Session has had time to see how the new worship space works out and determines additional needs.

We anticipate that Phase 1 will cost \$5,000 and will consist of the following: removing the existing structure and redesigning the stage, carpeting, paint and build the sound desk, the IT platform. We estimated the cost for this to be \$3,000, and for stage lights, LED strip lighting, connection cables and camera slider will cost \$2,000. The renovation work and the updating design in the front part of the Sanctuary will be done by a couple of professionals as well as members of KPC.

We have begun in the first part of June 2021 and we are planning to finish in the second part of July 2021. By that time, we hope to have our new cross finished and installed on the church building and to have a special service for the cross' dedication and the front part of the Sanctuary's renovation. The estimate expected costs is about \$ 6,500. Knox church Palmerston will contribute \$1,500 towards the Sanctuary space, and the IT and sound platform.

***Extract of Minutes from the Session meeting July 4, 2021.***
