EDICT AND NARRATION OF STEPS:

The Clerk, Wilma Welsh, entered the Sanctuary and read the Edict. The Edict was also read on October 21st and 28th, 2012 at St. Andrew's Hespeler Presbyterian Church, Cambridge.

SERVICE, ORDINATION AND SIGNING THE FORMULA:

The Court processed into the sanctuary. The service was led by The Rev. Scott McAndless
 The Clerk read the Narration of Steps.

The scripture readings were Mark 1:14-20, Responsive Gospel Reading Luke 12:22-34 and Acts 1:1-11 were read by Alexis Smith, Jean Godin and Penny Garrison.

The Rev. Penny Garrison, delivered the sermon. The title of the sermon was "Wanted: Willing witnesses. Full-time positions available, Great benefits. No experience necessary." The Charge "Lights, camera...action." was delivered by the Rev. Mark Gaskin.

The Clerk presented Richard Warne to the Moderator. With the appointed preamble and questions, the Moderator, the Rev. Linda Ashfield ordained Richard Warne to the Ministry of Word and Sacraments. Ordained clergy in the congregation were invited to come forward for the laying on of hands.

The Moderator then declared Richard Warne ordained to the Ministry of World and Sacraments, admitting him to all the rights and privileges belonging to this office.

The Presbytery was then called forward to give the right hand of fellowship after which the Formula was signed.

A Robe and Stole were presented by a delegation from Knox Jarvis and Chalmers Walpole.
